Institutional Spotlight

Each issue of the GEMNet-Health Newsletter highlights the current M&E activities of a member institution.

University of Ghana

The University of Ghana School of Public Health is one of the constituent institutions of the College of Health Sciences, University of Ghana. The school maintains a close working relationship with existing schools, institutes, and faculties of the University. It is one of the few African institutions that subscribe to the philosophy of “public health school without walls.”



Established in 1994, the University of Ghana’s School of Public Health has trained most of Ghana’s leaders in the health industry. The school has been responsible for training district directors for the Ghana Health Service and continues to train public health staff in different specialties. The school has offered short courses in monitoring and evaluation (M&E) and is currently preparing to run a full master’s program in M&E. The school is Ghana’s leading center of excellence for training, research, and innovation in public health. Funding for training activities is funded the World Health Organization (WHO) and the United States Agency for International Development (USAID), among others.

The faculty of the school includes renowned researchers contributing to world-class scholarly achievement and scientific discovery in infectious disease control, reproductive health services,




